ENROLLMENT

Selecting a Managed Care Entity

Your Skilled Nursing Facility (SNF) and Assisted Living (AL) waiver residents in the past few weeks may have received **mailings** and/or **phone calls** to select a PathWays managed care entity (MCE).

What residents need to have on hand when calling:

- Their Medicaid ID number;
- Their correct phone number and address on file with FSSA; and
- The name of their primary care provider.

Approved SCU and Vent Unit Provider Listings for the period July 1, 2023 -June 30, 2024

Myers and Stauffer posted the approved SCU and Vent Unit providers for the period July 1, 2023-June 30, 2024. We recommend reviewing this listing to verify that your facility is eligible for these add-ons.

REMINDER: Schedule Z must be filed by March 31, 2024, for any SCU or Vent unit applying to be eligible for the add-ons effective July 1, 2024. This is an annual requirement.
