# **CMS Delays Implementation of Surveyor Guidance**

- (CMS) released QSO-25-14-NH
- Updates guidance from November 18, 2025, and January
  15, 2025 significant updates to surveyor guidance
- Effective date from March 24, 2025, to April 28, 2025
- Revised surveyor resources will be released on April 28, 2025.

# **CMS Updates Training Plan for iQies Launch for LTC Surveyors**

- CMS announced last year its upcoming transition and training plan for State Survey Agencies to the Internet Quality Improvement System iQIES
- On March 7 CMS updated its plan that the IQIES Nursing home launch is scheduled for July 2025.
- This will not impact most providers but could change location for ePOC, the system many states use for survey plans of correction. – will let you know if Indiana will have changes in this area.



### **Assisted Living and Humana**

- Humana is the only MCE with a transition team for assisted living at this time.
- "As part of transition planning, prior to the member's physical move to the community, the Service Coordinator shall visit the residence where the member will live to conduct an on-site evaluation of the physical residence and meet with the member's family or other informal caregiver who will be residing with the member (as appropriate). The Service Coordinator shall include in the transition plan activities and/or services needed to mitigate any perceived risks in the residence including but not limited to an increase in face-to-face visits beyond the minimum required contacts."
